This letter is in support on behalf of Sandi Croft in requesting an O-1 visa. Sandi is employed by CDA Productions (Las Vegas), Inc. as a dancer for our production show, "A New Day" consisting of internationally famous Artist, Celine Dion at Caesars Palace in Las Vegas, Nevada. "A New Day" was created by Franco Dragone, Owner/Director of Dragone. For years, Mr. Dragone was the Artistic Director for Cirque du Soleil creating major productions including "O" and "Mystere".

The show premiered on March 25, 2003 and continually runs through November 2007 with renewal options. The venue seats approximately four thousand (4,000) individuals with one hundred sixty (160) performances annually. Ms. Dion sings live with musicians against a backdrop of dancers before the world's largest indoor LED screen displaying video scenery, all simultaneously.


In 2001, extensive worldwide auditions were held in Amsterdam, London, Paris, Montreal, Las Vegas, Chicago, New York and Los Angeles. A cast of forty-nine (49) dancers/artist were chosen. Sandi was chosen because she is a professional with a real inner soul that comes with an international reputation. She is an asset to any cast and is very much in demand. She is dedicated, energetic, and a spirited performer which has been proven time and time again throughout her extensive career. These are the same qualities that we found in her during the rehearsals. As a performer, Sandi has worked with the country star Shania Twain, the pop icons Salt 'n' Pepa, and with actor Val Kilmer in the 3D Imax film "Wings of Courage". Sandi has also served on panels of various dance and aerobic competitions throughout Western Canada and Asia. Through her education, experience and training she represents the highest

caliber of a dancer/artist; giving her critical skills and talent. Sandi is integral in our production; performing brilliant and daring dance maneuvers ranging from acrobatic and aerial feats to intricate and elegant dance combinations.

After the second year, "A New Day" continues to defy expectations, with sold out performances and unrivaled success creating the best spectacular performance on the Las Vegas strip and the number one (1) show in America. Sandi has an employment contract for a period of three (3) years and receives an annually salary of sixty-six thousand nine hundred fifty dollars (\$66,950.00). She is a dancer/artist of rare and extraordinary abilities.
